Call to Order & Welcome – Mike Ratchford

- Meeting called to order at 8:24 a.m.

A Winter Health Update for Cecil County was presented by Lauren Levy, JD, MPH, Health Officer, Cecil County Health Dept.

- *A lot of respiratory illness – Covid, flu, RSV – seen nationally*
 - **COVID** – *data less meaningful, based on confirmed PCR testing, does not include at-home testing*
 - *Currently at 7.33% positivity rate in 9/100,000 population (significant underestimate)*
 - *Seeing uptick after Thanksgiving*
 - **FLU** - *vaccination best protection (available at pharmacies & providers)*
 - *Preventive measures for all respiratory illnesses: Wash hands, cleaning/disinfecting surfaces, staying away from sick people, staying home if you are sick, masks are effective, vaccinations*
 - *Vaccinations: Covid vaccines age 6 months and up; age 5+ if more than 2 months since last dose); Bivalent boosters more effective against Omicron & latest variants*
 - **Respiratory Syncytial Virus (RSV)** – *pediatrics (age 5 and under) majority of cases*
 - *No treatment, no vaccine – wait out, let resolve, seek medical care if needed*
 - *Rates of infection dropping in past weeks*
 - **MPOX (Monkeypox)** – *CCHD offers vaccinations for high-risk population*
 - *Has been seen in countries not seen before; low numbers in Cecil County*
 - *Distinct skin condition (photos available on CDC)*
 - **Infectious Disease:** *Tests for Covid, flu and RSV; meds available if serious illness*
 - *Can receive Covid and flu vaccines at same time. Receive Shingles separately.*
 - *Take 4 weeks after vaccines for full immunity*
 - *Long term issues from Covid – concern is coinfections Covid+, RSV+, Flu+ cases; seeing long term effects from Covid-19 in older populations*
 - *CCHD has at-home Covid tests available*
 - *Current CDC regulations: isolate 5 days; do not return to work if still showing symptoms*

- Seeing high hospitalizations with RSV
- Every 3 years CCHD collaborates with Christiana Care Union – community health needs assessment (look at health conditions in County, data, interviews, focus groups, etc.)
- Report prepared to identify key areas (3 priorities identified)
 - Mental Health (focus on childhood trauma), substance use disorders, and access to health services
 - Mental Health – top priority
 - Seeing a lot of cases in young people; shortage of providers nationwide
 - PLAN:
 - Strengthen formal system of care: strengthen pipeline of candidates, licensing regulations, incentivize service providers from other counties/states
 - Strengthen Informal system of care:
 - Broad-based training/skill development – promote mental health & wellbeing, identify/intervene early signs of distress
 - RFP for mini grants – all organizations working in County eligible; excludes behavioral health providers
 - Use for staff training, activities that foster social connection with educational component
 - Supplement informal system of care
 - Overdose epidemic continues – part of overall Strategic Plan
 - Plan ambitious – will require all-County effort
 - Like to get business community involved in these efforts
 - Welcome EDC feedback, offer staff training, get RFP out there
- Overdose Support Team
 - Support families/children of OD trauma
 - CCPS work to support students identified as having experienced OD trauma at home (counseling, grief support, etc.)
- **Opioid Settlement**
 - Money coming – some coming to State for distribution, some coming directly to County
 - Strategic Plan for Overdose Response: Identifying high-priority activities for when money available
 - Talks re Crisis Stabilization Center for potential use, 24/7 facility
 - Cecil's OD rate 2nd only to Baltimore City
 - Pipeline for behavioral workforce
 - Data Platform – access for all agencies
 - Waiting to hear amount and flexibility for use of funds
 - Money to be disbursed over 18-year time span

Chairman's Report – Bill Sorenson for Mike Ratchford

- November 2, 2022, meeting minutes approved
- Appreciate Lauren's update; appreciate work this commission does

Director's Report – Update on Economic Development – Bill Sorenson, Director OED

- Upper Shore Micro Ag Grant -- Receiving MACo Award in Jan
 - Grant initiated by Maureen
 - Coordinated with Kent and Queen Anne's counties
 - Presented in late 2020; USRC board approved

- 1st year received \$48,000; 2nd year increased; leveraged more funding from MARBIDCO to add to grants
- Each county matched 1-for-1; Total \$305,00 in 2 years to go to grants for ag enterprises
- Partnership between 3 counties, 1 municipal organization, 1 state organization
- USRC already committed for grant program in 2023
- Also submitted application for MEDA Award
- Winter Nights/Cecil Lights – USRC funding again, 3rd year
 - Goal to brighten County, get people out to spend money in downtowns
 - Grant from USRC -- share with towns to purchase lights, plan activities
 - 7 towns participating this year
 - Some events planned: Chesapeake City Sip & Stroll, Lights, Wagon Rides, Fire Pits w/Smores, Night Hike, Soup Event, town decorating contest
 - Web page with info for towns/events
 - Tourism handles marketing (social media, billboards, print) for visitors & locals
 - Starts January 8th
 - MACo Award winning program
- MD 5 Star – 25,000 in attendance (small uptick from previous year)
 - Plan major marketing push to get word out in communities; have more companies sponsor
 - 1 of only 7 events in world

Maryland Technology Development Corporation (TEDCO) Update – Karen Zuccardi

- Take opportunity to meet everyone
- Intentional for building relationships with rural community
- Want to have office hours in Cecil County (possible Admin building, North East Library)
- Provide opportunities to give entrepreneurs access to State funding
- Present to schools, universities, community projects, workforce projects, etc.
- Offer presentation opportunities to support the ecosystem
- TEDCO created 24 years ago
- \$2.4B economic impact; helped create 10,000 jobs in State
- Maryland ranks third most innovative state in country

North East River Dredging Update – Woody Jackson

- Dredging going forward
- Good relationship with Corp of Engineers
- Performed soundings – spoil site at Cara Cove not enough room
- Had another site around St. Mary Anne's church -- plan adjusted and resubmitted
