- Friends of Cecil County Parks & Recreation Update: Provided by Thomas McFadden. The Betty Murray Memorial Scholarship fundraiser will be held on November 28th. Giving Tuesday is November 30th and the annual fund drive letter will be going out. The Cecil Springs event will be held on April 23rd at the Calvert Regional Park, a 5K is planned and non-profits in Cecil County will be invited to set up at the event. Food trucks will also be available. Brantwood Blooms planning is underway. This project is grant funded through the 2021 Delaware Sustainable Communities Grant. Preliminary planting maps are being created. A meeting with the Parks staff will be held to discuss exact locations. The next Friends meeting will be held on December 7th. Arts in the Park planning is underway. The committee will be meeting on November 30th. Driftwood structures will be the focus. A disc golf fundraiser is being planned. Board member Mike Kline has resigned. Candidates for the Friends Board were sent board member packets.
- General Update: Provided by Clyde VanDyke. The last tournament of the year will be held on Sunday, November 21st. The new basketball program has over 230 registrations. We are working to fill an opening on the Programming side. We continue to work on updating the 2022 Land Preservation Parks and Recreation Plan. Infrastructure fund applications have been submitted to the state. Two of three applications have been approved. The Department is appreciative of the Friends and all they are accomplishing.
